A Budget Explained by Mike See 2022 Profit / Loss Spreadsheet

Revenues: Connection fee: one-time fee of \$1500.00 and it includes installation plan review, engineering reviews and inspections. Possible lower connection fee & charge more fees up front for plan review etc.

Concerns of the infrastructure and amount of money to cover what might be coming up. Tanks are getting old, and it is possible to be replaced. Lambs drive water line is undersized. (IFFP)Transfer station reaching capacity will need upgraded. Reimbursement fee for tank water. Gardner & Johnson CMWC has not put any money into the building of the tanks. Heidi question about water right to Johnson to drill the well.

Expenses: Need for more Neptune Meters. With the heavy snow level some meters are not being able to be read. Metes are back ordered. Have 200 Neptune meters now being used. Taxes, banking fees, Professional consulting, Legal fees. Audit fees they can do a compilation audit or a full audit. The board decided to have a full audit due to being a new board and do the compilation audit next year.

## Engineering fee IFFP report

Computer & software for both types of meters to read and bill. There is a total of 854 meters and only 210 are Neptune Meters. Have been replacing as the older ones go out, around 8 years old.

Discussion regarding Jennifer position. Dave and Earlene will go into the office on Monday. Earlene will speak with Jennifer regarding her responsibilities and how to do them. Dave will meet up with Mike to finish going over the remainder budget and give the other board members a review.
